Section 1.

The prohibitions declared by section 18 of the "Game Act," being chapter 135 of the the "Game Act," being chapter 135 of the "Revised Statutes of British Columbia, 1948," as to the hunting, trapping, taking, wounding, and killing of game, are, subject to the provisions of sections 2 to 9, inclusive, of these visions of sections 2 to 9, inclusive, of these visions, hereby removed to the extent and regulations, hereby removed to the extent and within the period and limits and subject to the provisions hereinafter set out respectively, as follows:—

For the purpose of defining the open seasons for big game, game birds, and the trapping of fur-bearing animals, the Province shall be divided into two districts, to be known as the Western and Eastern Districts.

WESTERN DISTRICT" shall mean and

"WESTERN DISTRICT" shall mean and include all that portion of the Province situate and lying to the west of the summit of the Cascade Mountains and south of the Electoral Cascage Mountains and south of the Electoral District of Atlin, except that portion of the Electoral District of Skeena covered by the watershed of the Lakelse and Zymagotitz

"EASTERN DISTRICT" shall mean and include all the remainder of the Province.

All times mentioned in these regulations refer to Pacific Standard Time unless otherwise specifically mentioned.

(f) MOUNTAIN-COAT, over one year of age, north of the 56th parallel of north latitude, open season from August 15th to December 15th.

(g) WAPITI (ELK), of the male sex, over one year of age, in the Fernie and Columbia Electoral Districts, open season from September 15th to November 30th.

(w) EUROPEAN PARTRIDGE, no season anywhere in the district.

(x) GROUSE (BLUE ONLY), throughout Vancouver Island, Nanaimo and The Islands Electoral District (except North and South Pender Islands), and those portions of the district situate and lying north of a straight line running from Oyster River, on Vancouver Island, to Sarah Point, on the Mainland, open season from September 10th to October 31st.

BAG-LIMITS (EASTERN AND WESTERN DISTRICTS).

BIG GAME.

In respect of big game as defined in the "Game Act," no person shall, throughout the Province, at any time kill or take or have in his respection during the action his possession during the entire open season more than one CARIBOU, one MOUNTAIN-SHEEP, all of the male sex, over one year of age, and not more than two MOUNTAIN-GOATS over one year of age, and, further, the combined or total seasonal beginning for combined or total seasonal bag-limit for MOOSE and WAPITI (ELK) shall be one, of the male sex, over one year of age.

Throughout the Province no person shall kill or take or have in his possession more than one GRIZZLY BEAR, except in that portion of the Province situate and lying north of the 57th parallel of north latitude and west of the Rocky Mountains wherein the bag-limit for the entire open season shall be two GRIZZLY BEAR, and, further, there shall be no bag-limit on BLACK or BROWN BEAR. Throughout the Province no person shall at

Throughout the Province no person shall at any time kill or take or have in his possession during the entire open season more big-game animals than the maximum number permitted to be killed, taken, or had in possession in any district.

No person shall, in any district hereinafter designated, kill or take on any one day any greater number of game birds than the daily bag-limit hereinafter set out respectively, nor kill or take or have in his possession during the artise cores. the entire open season more game birds than the maximum number permitted to be killed, taken, or had in possession in any district.

Section 2.

The prohibitions declared by subsection (1) of section 26 of the "Game Act" as to the buying, selling, and having in possession of big game, so far as same relate to game lawfully killed or taken, are hereby removed to the extent and within the periods and limits and subject to the provisions hereinafter set out as follows: out, as follows:-

(a) MOOSE and CARIBOU, bulls over one year old, in the Atlin and Omineca Electoral Districts, north of the 57th parallel of north latitude, from September 1st to December 15th.

(b) BEAR (except White or Kermodei Bear), throughout the Province, at any time

during the open season.

Section 4.

No person shall at any time kill or attempt to kill any Migratory Game Bird, Pheasant, Partridge, or Quail with a rifle, or hunt, as defined in section 2 of the "Game Act," any game birds in any field or on or over any cultivated land by using an automobile or other vehicle thereon.

No person shall discharge a firearm over, on, or across any travelled road or highway within the boundaries of any municipality, or within the boundaries of the Electoral Districts of Esquimalt, Cowichan-Newcastle, Dewdney, and Chilliwack, and in the North Saanich Districts or any trunk and main highways anywhere in

the Province.

No person shall hunt, kill, or attempt to kill any Migratory Game Bird by the use or aid of baiting, and no person shall hunt, kill, or attempt to kill any Migratory Game Bird within one-half mile of any place, reserved or otherwise, where baiting is being done or where it has been done less than fourteen (14) days before the first day of the onen season for has been done less than fourteen (14) days before the first day of the open season for ducks or geese in the district in which the said place is situated; and in this section baiting means placing or exposing corn, wheat, oats, or other grain, or products thereof, or any food or other materials which may have the effect of attracting wild birds.

No person shall build or construct, at any place in the Province before the day prior to

place in the Province, before the day prior to the first day of the open season for Migratory

Game Birds at that place, a blind of any kind that can be used in connection with the hunting of the sai igratory game birds.

The use of the decoys in the hunting or taking of any Migratory Game Bird anywhere

in the Province is prohibited.

The use of any shotgun equipped with a reflector sight of any kind in the hunting or shooting of game birds is prohibited.

Section 5.

The open seasons declared by these regula-The open seasons declared by these regulations shall not apply to the hunting, taking, or having in possession of Quail, Pheasant, Prairie-chicken (Sharp-tailed Grouse), or Partidge at any place when the surface of the ground at that place is covered with snow.

Section 6.

No person shall hunt, kill, or take any Moose, Caribou, Wapiti (Elk), or Deer while swimming, and the hunting, killing, or taking of any game by the use of tracer bullets, tracershot shells, and bow and arrow is prohibited. In the hunting of big game the use of any rifle loaded with rim-fire shells, the use of full steel (hard point) metal-cased bullets, and the use of any firearm that can be or is classed as a machine gun or sub-machine gun is prohibited. This regulation is not intended to prohibit the use of arms of the self- or autoloading types in which the recoil or force of the explosion is utilized to reload but not to the explosion is utilized to reload but not to fire the weapon.

The killing, trapping, or taking of any furbearing animals by the use of spring-pole traps anywhere in the Province is prohibited.

Section 7.

Every person shall, upon the request of any Every person snan, upon the request of any Game Warden or Constable, furnish satisfactory proof to him of the locality and date on which any game was by him killed, taken, or

regulations, shall mean and incince Moose. Caribou, Deer, and Wapiti (F. No person shall have in h. possession the carcass of any member of the Deer Family or Mountain-sheep from which all evidences sumcient to indicate conclusively the sex of the animal have been removed, unless the carcass has been transported to the place where it is proposed to consume the carcass. When head is removed from carcass, some other evidence of sex must be visible.

Section 8.

No Bear shall be trapped anywhere in the Province. The hunting or shooting of Deer by the use of a shotgun is prohibited throughout the Eastern District.

Section 9.

No guide shall guide more than two persons at any one time on any big-game hunting-trip.

After careful consideration it has been decided to ask the co-operation of all hunters to adopt a uniform DISTRESS SIGNAL, as follows: "Any hunter in the field, in case of accident distress or otherwise should as a accident, distress, or otherwise, should, as a signal, fire three shots, allowing a space of five signal, fire three shots, allowing a space of five seconds between each shot, and should anyone hear this signal he should reply by firing one shot. DISTRESS SIGNAL to be given, if possible, until replied to. If after a signal has been replied to, the party in need of assistance should repeat his first signal, but if not in need of assistance it will not be necessary in need of assistance it will not be necessary

NOTICE TO PROSPECTORS.

A prospector as defined under the "Game

Prospector' means a person who is the holder of a free miner's certificate under

the 'Mineral Act' or the 'Placer-mining Act' and only while be 's actually engaged personally in (er-mining or prospecting."

Any bona-fide prospector who is the holder of any licence to carry firearms under section 34 of the "Game Act" may, during the open or close season in any unorganized district as defined above, hunt and kill and retain in his possession any grams for his own was the second to the second for his own was the possession any game for his own use when in actual need of same for food.

Any bona-fide prospector in an organized district as defined above may hunt and kill and retain in his possession any game during the open season when in actual need of same for food, and in an organized district during the close season hunt and kill and retain in his possession any animals of the deer family, other than wapiti, of the male sex, over one year of age, after having obtained a permit therefor.

NOTICE TO NON-RESIDENT BIG-GAME HUNTERS.

"ANY NON-RESIDENT HUNTER, order to export trophies secured, must obtain a permit for this purpose from any Game Warden, Provincial Constable, or Government Agent. This permit will be issued upon payment of the fees due on trophies being exported as set forth in the regulations.

"NON-RESIDENTS of the Province hunting big game must be accompanied by a British Columbia licensed guide, or a resident under special permit from the Game Commission."

Hunters who wish to ship their trophies from the Province must comply with the provisions of the "Game Act" and the Dominion Customs Regulations in that regard.

The following is a summary of the Customs and Game Regulations, which are being furnished for the convenience of non-resident biggame hunters:-

REGULATIONS.

" Declaratio orm in connection with the Export of Me and Deer (copy of which form can be secured from any Express Agent) must be duly completed. With this declaration the hunter must personally appear before a Canadian Collector of Customs, and only when approved by him and form returned to the Express Company will shippent be now the Express Company will shipment be permitted to leave Canada.

"Customs invoices and Export Entry Forms

must also be tendered with the shipment.

"Note. — Should there not be a Customs Officer at point of shipment, consign trophies to yourself at nearest Customs export point, have form completed on your arrival there, and deliver to the Depot Agent of the Express Company with request to reforward shipment to destination."

NOTICE TO SPORTSMEN.

All sportsmen are asked to co-operate by obtaining their firearms licences early in order to assist in eliminating the usual last-minute

Any resident firearms licence-holder must, in hunting deer, moose, or wapiti (elk), be in possession of the required tags for tagging any such animals shot in accordance with the Gametagging Regulations.

No credit can be given for unused deer, moose, or wapiti (elk) tags.

Fees: Deer-tag, 25 cents each; Moose-Elk

THE GAME-TAGGING REGULATIONS APPLY TO RESIDENT AND TO NON-RESIDENT HUNTERS.

Hunters are requested by the Game Commission to refrain from killing female bear when it is known they are accompanied by cubs. Do not shoot, take, or molest bear cubs.

From now on, if at all possible, fishermen obtaining resident anglers' licences will be supplied with copy of the British Columbia

Special Fishery Regulations showing open seasons, etc.

LICENCE-HOLDERS HUNTING IN A MUNICIPALITY ARE ADVISED TO ACQUAINT THEMSELVES WITH ANY BYLAWS COVERING THE DISCHARGE OF FIREARMS THAT MAY BE IN EFFECT THEREIN.

A SPECIAL MESSAGE TO TRAPPERS.

The Game Department is extremely anxious to impress upon all trappers the necessity of preserving their fur-bearing animals, especially beaver. Trappers should refrain from trapping these animals unless they have sufficient number on their trap-line to warrant trapping. Beaver must not be trapped unless the Beavertagging Regulations set forth herein are fully complied with.

The Game Department will give trappers who try to conserve their beaver, as well as other fur-bearing animals, all the assistance in its power to protect their lines from poachers, but, on the other hand, will cancel the lines of those trappers who wilfully overtrap.

Registered trappers are particularly requested to adhere to the following:-

- (1) Do not overtrap; conserve the furbearing animals on your trap-line.
- Plainly mark your trap-line and refrain from trespassing on any other trapper's line or private land.
- (3) Please make your application for renewal of your registered line and your return of catch covering the past season's operations after the expiration of your Special Firearms Licence, or at least before September 30th, as failure to renew or submit your return of catch may place your application for registra-tion in line for cancellation. Trappers must surrender their Resident Special Firearms Licences upon expiration,

(4) Report every violation of the "Game Act" or regulations immediately to the nearest Game Warden or Provincial

(5) Suggestions for improvement of the Trapping Laws will gladly be received at all times and given careful consideration by the Game Department.
 (6) Remarks

(6) Remember that the use of poison or pitlamps in taking fur is prohibited.

(7) Sale or transfer of any registered traplines is prohibited except under certain conditions, and only on permission of the Game Commission.

(8) White men and Indians are urgently requested to co-operate in conserving fur-bearing animals.

(9) PREVENT FOREST FIRES. Report any forest fire immediately to the near-est Fire Warden, Game Warden, or Provincial Constable.

(10) Under 1931 amendments to the "Land Act," it is provided that where any land described in any application for preemption record comprises an area situate within the limits of a trap-line registered under the "Game Act," the Minister of Lands and Forests may direct that the pre-emption record shall be granted subject to the continued exercise by the registered holder of the trap-line of all its rights thereto or thereunder, including the exclusive rights of trapping over that area, for a period of not exceeding two years from the date of the pre-emption record, in which case the Minister of Lands and Forests shall cause a notation to be made on the certificate of pre-emption record for entry in the Land Office register and notice thereof to be given to the pre-emptor.

FUR SALES.

(11) Every fur-trader, in chasing fur, must insert in his record-book the number of the licence of the person by whom the pelts or skins of fur-bearing animals were trapped.

FUR SHIPMENTS.

(12) No person shall make any shipment of any game, or any part thereof, or the eggs of any game bird, whether for export or to a destination within the Province, by any railway, steamship, or express company, or other common carrier, without first preparing the shipment so that the package or receptacle used for purposes of the shipment may be easily opened for examination of the contents, or else by preparing the shipment by plainly marking on the outside of the package or receptacle, or on a label securely attached thereto, a full description in detail of the contents; and no person shall make any shipment of any game, or any part thereof, or the eggs of any game bird, whether for export or to a destination within the Province, without first plainly marking on the package or receptacle used for purposes of the shipment, or on a label securely attached thereto, the names and addresses of the consignor and consignee of the shipment respectively, and also the number of any licence issued under the "Game Act" to the consignor.

REGULATIONS COVERING THE SEALING OF BEAVER-PELTS.

(Order in Council No. 1639, approved July 16th, 1948.)

1. For the purpose of these regulations, the words "pelt" or "pelts" when used herein shall mean a beaver pelt or pelts.

2. Any pelt repelts trapped, taken, or he possession any person in the Provin in possession must be sealed with a seal prescribed and st plied by the Game Commission, and such se must remain on the pelt until the pelt is to manufactured.

3. (a) Upon application, the Game Comm sion or its authorized agent shall issue or cau to be issued, provided the applicant is qualified trap, a permit and the number of beave seals deemed to be sufficient to ensure the proper harvesting of beaver in any trappiarea or on any lands whatsoever, and the Garage of the seals are a commission shall have power under these re-Commission shall have power under these re ulations to appoint any person to issue permi

and beaver-seals.

(b) No permit or seal is to be issued unle the issuer has proof that beaver are established. on the trapping area or lands for which appl cation is being made to trap beaver.

4. Each applicant for permit to trap beave shall on issuance of permit be supplied wit the required number of seals.

5. Each applicant for beaver-seals and permit shall, when requested so to do, furnis satisfactory proof to the Game Commission of its authorized agent as to the trapping are where it is proposed to trap the beaver.

6. One of the seals supplied must be secure.

7. Each person to whom beaver-seals haves been issued shall return any unused seals forth with after the close of the authorized trapping period to the nearest Game Warden or Con-

8. The transfer of any beaver seal, seals, or permit from one person to another is pro-hibited, and no person shall have in his possession any beaver seal or seals or permit not issued in his name.

9. No trapper, fur-trader, or any other person shall buy, sell, or offer to buy or sell, possess, bargain, or trade in any pelt that has

10. All imported pelts shall be sealed with a seal designated by the Game Commission; provided that the onus of proof that such pelts have been legally imported shall at all times be the responsibility of the persons found in possession thereof, and no pelts shall be sealed until such proof is produced.

11. No common or private carrier or transportation company or person shall carry or cause to be carried, shipped, or transported within the Province any pelt that has not been sealed in accordance with the provisions of

these regulations, except in a case where a pelt or pelts have been confiscated to the Crown.

HELP PREVENT FOREST FIRES.

of It is unlawful:

To use any swivel, set-gun, machine gun, or battery, or any gun larger than a 10-gauge, or a pump or automatic shotgun without a per-

manent plug—magazine to hold two shells.

To hunt any game birds between one hour after sunset and one hour before sunrise, or during the prohibited time or period mentioned in the Game Regulations.

To carry loaded firearms in or on or discharge same from an automobile or any other vehicle either on or off a highway.

To carry firearms in an automobile, launch, sailboat, or power-boat during the close season on game without a permit issued by the Game Commission.

To have in possession, place, or set poison for the taking or killing of any game.

To use pit-lamps or lights of any description at any time for the purpose of hunting game birds or animals.

To remove all evidence as to sex from any member of the deer family or mountain-sheep which have been killed until the carcass or carcasses of said animals have been taken to place of consumption.

moose, wapiti, or deer at any time, or to r at large hunting game birds between April 1 and July 31st, both dates inclusive.

To angle for fish in non-tidal waters without the state of the sta

To kill a deer and retain same in possessi before taken to place of consumption withe first tagging the carcass of the deer by inser ing the tag through the flesh or skin of t animal in accordance with the Game-taggir Regulations, and this rule also applies moose and elk.

To frighten or disturb any game birds the waters of any game reserve by the dicharging of any rifle or firearm, or by the firm of shots from a rifle or other firearm, upo over, or across any game reserve.

Full co-operation is respectfully requested of all licence-holders in submitting their gam returns on form supplied by the British Colum bia Game Commission.

PREPARATION OR CARE OF GAME MEAT.

BIG GAME.

1. Go prepared. The following equipment is either essential or desirable in the care of a big-game carcass: Hunting knife, belt axe, 30 feet of 1/4-inch rope, some twine, several pieces. feet of 4-inch rope, some twine, several pieces, of clean wiping cloth, four (4) muslin or cloth sacks, each large enough to hold a quarter of the animal, and several pieces of old but clean the meat on canvas for use when carrying the meat on

2. As soon as possible after the animal is shot insert the knife at the point of the brisket with back of the blade against the breastbone, point the tip toward the backbone at the top

To hunt gar from any sailboat, power-be cut diagonally forward towar in head to sever the large blood-vessels in the neck. If To hunt gar from any sailboat, power-be cut diagonally 191741.

To use any other person's licence or perm or to loan or transfer any licence or perm possible, first turn the animal with its head under any circumstances.

To allow any dor to hunt or run any carib.

3. After the animal has bled well, turn the carcass with head up-hill and open it from the vent to the throat. Use the hand axe to break the pelvic bone and breastbone. Be careful not to puncture the intestine or paunch. If the animal is first placed on an incline, the paunch and intestines will roll out more freely. Slip your knife forward between the ribs and the paunch (stomach) and cut the muscular dia-phragm loose. Cut the windpipe and gullet free as far forward as possible. Take the windpipe and gullet in the left hand and pull backward, at the same time cutting free from

the carcass that portion which tends to hold.

4. In the case of deer, place the carcass in position to drain. Wipe the inside of the carcass dry with clean cloth. Do not wash with water. Remove the dark tufts of hair on the hind legs. These are glandular areas which secrets a foul-smelling material that may consecrete a foul-smelling material that may contaminate the meat. Before using your knife again, you should carefully wipe it clean. The testes left on the carcass will cause no harm.

5. In case the carcass cannot be hung up or is not removed to camp immediately spread it open with a short spreader-stick across the chest to cool as rapidly as possible and prevent meat from spoiling. Do not leave a carcass exposed to the sun; drag it to a shady place. Certain additional precautions are necessary in the treatment of moose or elk. The carcass the treatment of moose or elk. The carcass must be propped open in several places to permit rapid cooling. Make sure that the pelvis also has been split and propped open to allow the large mass of meat in the hindquarters to cool as rapidly as possible. Roll the animal on its back so that the warm air and steam which rises from the body cavity may escape and speed up the cooling process and that the

maximum area may be exposed to the air.

Never leave rm meat in the cloth or canvas containers.

Apack the meat from the cloth or muslin sacks each night and allow it to hang in a cool, dry place. When horses are used for packing, the meat should be wrapped in clean canvas with the hair side toward the horse. Packing should be done only after the meat has become cooled.

6. When the entire carcass is to be transported, leave the hide on the animal to prevent the meat from becoming soiled and drying out.

7. If it is desired to save the head and scalp for mounting, do not stick the animal in the throat. Open the skin squarely on the side of throat. Open the skin squarely on the side of each shoulder, skin down to the leg on one side, cut across to the other leg, preserving the brisket skin intact. Roll the animal over and skin down from the shoulder in the same manner until the cuts meet. Then, starting on top of the animal and between the shoulders, open the skin at the back of the neck almost to the antlers. Pull the skin free from neck and shoulders and up to the head. Then, and not until then, open the animal's throat and bleed in the usual manner. A neck skin cut where in the usual manner. A neck skin cut where the usual inexperienced hunter thinks is proper will be eight to twelve inches too short for good mounting.

UPLAND GAME BIRDS.

Grouse often require particular attention, as they are killed early in the season when the weather is still warm. Special treatment is weather is still warm. Special treatment is also necessary due to the berry juices that leak from shot-holes in the intestines and stain the meat, often imparting a strong flavour to the flesh. For this reason it is advisable to remove the vicence from groups (particularly blue) the viscera from grouse (particularly blue grouse) as soon as they are killed. Make a small incision near the vent large enough to insert two fingers, and pull out the contents. When the birds are prepared in this way, it will be necessary to make doubly sure that flies do not gain access to the incision. Do not leave

birds in a hunting coat or piled in a car trunk. Hang them in a cool place, encl in a muslin sack to keep out the flies. It advisable to clean all game birds, including water-fowl, soon after they are shot, or removed to a place of residence in order to prevent the intestines from leaking and the juices tainting the meat.
